SAMPLE CHARTER AGREEMENT

WE PROVIDE:

CHARTER DATE: Your charter date and time are confirmed when we have received the signed Ashes At Sea (AAS) Charter Agreement and payment in full.

CHARTER TIME: We board prior to charter and leave on time. Late arrivals will miss the boat. You may delay a maximum of 10 minutes, then we must cancel without refund. You may reschedule at the first mutually available time for the full fee.

OUR RESCHEDULING: Due to inclement weather (USCG "Small Craft Warnings") or equipment failure, we may reschedule at no additional cost to you.

CLIENT RESCHEDULING: You may reschedule or cancel 1 to 6 person charter vessels with 72 hour notice, 7 to 49 person charter vessels with 7 day notice and over 49 person vessels with 2 week notice, without charter violation. **REFUNDS:** Are subject to a \$35.00 administrative charge.

NO REFUNDS: If this agreement is violated.

PHOTO POLICY: We document the release of ashes. We will document the entire charter upon your request _____(initial).

PHOTO JOURNAL: You may select your one COURTESY SHOT and return the rest within one week (postmarked) for no charge. All photos are protected under © and may not be reproduced or sold. All ocean shots remain the property of Ashes At Sea Inc.

ASHES: It is your responsibility to deliver the ASHES to AAS and to provide an accurate California Disposition Permit.

CHARTER GUESTS: It is your responsibility to provide them with directions to the vessel. Only the legal number of guests agreed upon will be permitted to board. Children and infants require prior notice at time of booking. We do not allow explosives or weapons on board. We reserve the right to deny boarding to any guests that we determine to be unsafe for travel. We reserve the right to cancel any charter at any time for unlawful behavior and/or non co-operation with the Captain according to USCG rules and without refund.

TRAVEL RELEASE: You and your guests board the vessel at your own risk. Your signature below is confirmation that you agree to all terms of the agreement and you accept full responsibility and liability for loss of life, guest injury or illness, property loss and damage to this vessel caused by you or your guests. Furthermore, you shall hold Ashes At Sea Inc., its personnel, agent, Captain or crew blameless according to Federal, State and local law.
